## Jean R. Cleland (1923 - 2013): Embodiment of Peace and Justice

Jean R. Cleland embodied the phrase, “If you want peace, work for justice.” Jean never shied away from controversy, from doing what was right, what was “open-minded and enlightened” – “what Jesus would want me to be doing,” she recently said.

Jean was a founder of Open Communities in 1972, then called the North Shore Interfaith Housing Council. Before this, she was an integral part of the grassroots North Shore Summer Project that aimed to integrate the housing market against rampant discrimination against “Negroes, Jews, and Orientals.” Jean chaired the Wilmette Housing Commission when the Village created it in 1980 and was instrumental in getting Gates Manor (the suburb’s first low-income rental building) built in Wilmette on land owned by her church at the time, First Congregational U.C.C.

Jean and her husband Bob were about, and embodied, **welcome**. Whether it was as a large family with six children, as next-door neighbors, as community, interfaith and church leaders, or as people who would shelter families during the Sanctuary Movement, they were clear, grounded and warm. Both of them lived the credo, “To those whom much

## Fair Housing Protections Extended to Vouchers

Open Communities and Chicago-area colleagues such as the Metropolitan Tenants Organization, the Shriver Center on Poverty Law, and the Chicago Lawyers’ Committee for Civil Rights Under Law are cheering a major fair housing success.

As of August 2013, capping a 10-year campaign, voucher holders in suburban Cook County are fully protected under the County’s Human Rights Act. Landlords can no longer disqualify anyone just because they have a voucher, just like they can’t deny the opportunity to apply based on race, color, national origin, religion, sex, disability, age, presence of children, sexual orientation, or military discharge status. Before the change, tenants were protected from discrimination based on lawful source of income such as child support and Social Security, but vouchers were excluded.

Since voucher holders are disproportionately African Americans, single-parent households, and people with disabilities, this new protection will promote integration.

Cook County has over 15,000 Housing Choice Voucher holders. Kudos to County Commissioners Jesus “Chuy” Garcia, Robert Steele, and Larry Suffredin for their leadership, with the staunch support of Cook County President Toni Preckwinkle. Voucher holders “need to be able to use the vouchers in great communities where they want to live,” said Commissioner Suffredin (13th District).

We look forward to working with landlords, tenants, and municipalities to further inclusive and welcoming communities!

## Homesharing for Young Musician

"We were able to calm the fears of a New Hampshire mother whose 18-year-old daughter had been accepted to school in the area," said Jackie Grossmann, our Homesharing Coordinator. The mother worried that, "We don't know anyone in Chicago. My daughter has never lived in a big city and she won't have a car to get to school. This is my daughter's dream. How can we be sure that she will be safe and able even to get to school?"

Through Homesharing this young renter was welcomed into the home of a Skokie woman five blocks from her violin school. This is a "win-win" match. The homeowner benefits from the companionship and the \$500 more a month. The young renter is in a well-maintained home near school and her mom is breathing a sigh of relief!

## Niles Homeowner Saved

The economic downturn did not spare an elderly Filipino nurse, a Niles homeowner of many years. With her hours cut in half, she turned to so-called "experts" who took her \$25,000 and did nothing. She could not even get a loan modification. Thanks to Open Communities' staff, in August she and her husband were approved for a trial loan modification, dramatically decreasing her payments with a potential principal reduction of over \$200,000. Expressing her gratitude, "Anna was so wonderful, honest and knowledgeable in giving me the guidance."

Open Communities is HUD-certified to provide one-on-one and group housing counseling services to prevent foreclosure, mortgage scams and lending discrimination. Our multi-lingual counselors are fluent in Polish, Russian and Spanish.

## Transit-Oriented Development in Skokie

Through a grant from the Sally Mead Hands Foundation we are collaborating with the Center for Neighborhood Technology to study and create a model plan/ordinance for Transit Oriented Development that includes housing for all people. We will be using the principals of Affirmatively Furthering Fair Housing to create an equitable plan. We are working with the Village of Skokie as our model community and specifically looking at the Oakton Street Station. The goal is to combine economic and residential development to create an area that is walk-able, accessible, affordable, and equitable for all people.

## Parent Mentor Program Expands in Skokie

In late November 2012, the Niles Township Schools’ ELL Parent Center invited Open Communities to partner with them in this innovative parent involvement program to bring it to two schools in Skokie. For the 2013-2014 school year, we have added four other schools in the Niles Township. The schools now include Madison, Devonshire, Fairview, Highland, Meyer and Stenson. Our group will exceed 50 people!

In this program, each Parent Mentor is assigned to a classroom at their child’s school (not in their own child’s class) where they are matched with a teacher and work one-on-one and in small groups with students. Not only are teachers getting extra assistance, but children are learning skills from these individuals who have so much to offer. In addition, teachers get to learn about another culture and parents get extra training and experience for their future endeavors.

As we work to build more diverse and inclusive communities, it is programs like this that really accomplish that vision.
